2016 HIGHLIGHTS:

- Over **2,364 People** participated.
- **38 Activities in 12 Communities** across the state were reported.
- **28 Proclamations** were issued by the state, counties, cities, and one school district.
- **300 copies of *Forgiving Others, Forgiving Ourselves*** were distributed. Additional conflict resolution books donated by community organizations and practitioners were also distributed.

Most of the reported activities were a direct result of the Conflict Resolution Month in Colorado campaign. Other event sponsors planned programs during October and included them in our website calendar. Additional events took place without being posted and are not in this summary.
